SCHOLARSHIP AWARD RULES

Awarded to California High School seniors who are in this state legally for their use as full-time students at any accredited public or private college, university or trade school. Scholarship recipients must start attendance within 12 months of the award and show proof of enrollment in a minimum of 12 credit hours.

Essay subject is: **“Importance of Establishing and Maintaining Good Financial Credit During Your College Years”**. Entries must be typed, 12 point font, double spaced, and be between 700 and 1,000 words (include word count at the top of your essay). Please **DO NOT** put your personal information on any page, and please do not staple your essay.

Each entry must include the completed application, signed by the applicant and his/her parent or guardian, and the essay, and must be submitted at the same time. DO NOT submit application and essay more than ONCE.

Semi-finalists will read their essay and be evaluated by a panel of judges who will determine the final placing. The decision of the judges is final.

By submitting your entry, applicant and parent or guardian agree to all scholarship rules set forth in this document.
